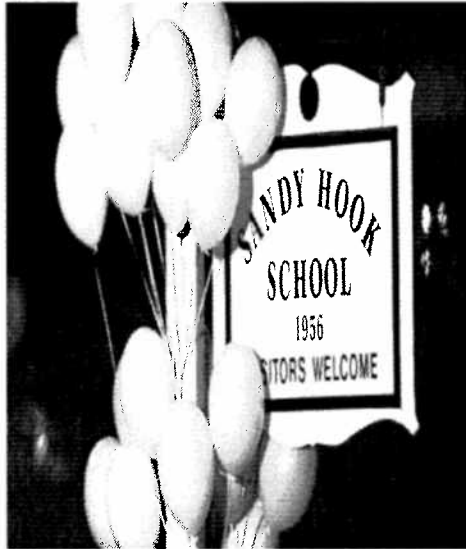

This presentation provides schools and businesses a hands-on approach in responding to a violent and deadly attack, by providing them with basic tactical considerations for survival!

This presentation provides three one hour blocks of instruction on:

- History of Active Shooter Incidents
- Protecting yourself and others
- Incident Command System

History

This block of instruction provides information on the history of active shooter incidents in our society. You will have a better understanding of the mindset of active shooters, the affects that active shooter incidents have had on law enforcement and society, and trends relating to active shooters in the past, present and future.

Protecting Yourself and Others

This block of instructions provides practical/ tactical considerations to help survive an active shooter incident. This includes helpful actions you can take inside a facility. Proper ways to communicate with law enforcement as they respond to you. What type of actions law enforcement will take when they respond and why. Basic first aid considerations you can take when needed.

Critical Incident Command

This block of instruction explains the National Incident Management System (NIMS). It will discuss NIMS role at a critical incident, the role you may play, and it's affects on training and threat resolution.
